Thesis: Campus Foodscapes as Sites of Transformation: Mapping policy and projects in US universities envisioning just, sustainable, and healthy food systems

Supervisors: Prof. Christine Parker and Prof. John Howe

This research included fieldwork across eleven US universities and interviews with practitioners in campus foodscapes, including academics, professional staff, and students to understand their experience working for transformative change within institutions. This research presented insights into the emergence of policies, projects, and protests to envision and enact more just, sustainable, and healthy food futures and identified drivers and barriers to change. It defined higher education, and institutional foodscapes, as a critical site for future research. Key actors in this field were identified ranging from community-driven activism and grassroots projects, through to the power held by multinational corporations and their activities and influence in educational settings. Further, data was collected through institutional reporting schemes which resulted in a detailed understanding and typology of the activities, infrastructure, and stakeholder networks. This research used frameworks from critical food studies and institutional ethnography, with methodologies including semi-structured, open-ended interviews, grounded theory construction, as well as document and discourse analysis from institutional and corporate sources. Results included: detailed discursive analysis; 22 maps of campus and higher education foodscape activities, elements, stakeholders, and networks; vignettes of exemplar projects; and case studies illustrating the impact of corporate agendas in these settings. Masters' Thesis 2016-2017

Nestlé's MILO: An analysis of a Global Brand to Understand the Food Industry's Attitudes to Corporate Social Responsibility, Regulation, Public Health, Diet and Physical Activity

Supervisor: Dr Gyorgy Scrinis

This research undertook a detailed analysis of a single-brand, Nestlé's Milo, to generate deep insights into how the food industry secures influence, both with consumers and policy makers. The research found that Milo is sold in 53 countries, primarily Low and Lower Middle-Income Countries and aggressively marketed via community and school sponsorships in the form of sport and physical activity programs. It found that these programs are not regulated by current marketing to children policies. This research used existing research methodologies from public health nutrition practitioners to gather corporate reports, websites, social media channels, newspapers, product packaging and popular media. These findings were considered against World Health Organization recommendations and the recommendations of the International Network

for Food and Obesity Research, Monitoring and Action Support. Although these programs were promoted as corporate social responsibility activities by Nestlé, they were found to be heavily branded, and marketing to children through sponsorship, which is largely ignored by current regulatory frameworks. This research identified Nestlé systematically link sport and physical activity programs with nutrition education programs that promote legitimacy for their products. Nestlé targets LIC and LMIC markets and exploits weak governance structures to install corporate education programming through Milo school programs. The research also identified extensive political activity and lobbying and the continued practice of the corporation publishing and promoting self-funded research. Awarded 92.
